Gather these items together and make each document into its own pdf. An email invitation will come to you for the onboarding process with the hospital. Their team are available for technical issues, if needed. Approval by the hospital is required before setting the dates to attend the workshop.

## Please be prepared to submit:

- 1) Background Check (PICC Excellence will take care of this for you, after you have purchased)
- 2) 5 Panel NIDA Drug Screening
- 3) Immunizations: (must have records, please make pdf docs of each, these will be uploaded to the hospital onboarding system into its respective field)

Influenza – Proof of Influenza Immunization (in season)

**COVID-19** – Proof of Vaccine (exemptions handled individually)

## MMR (Measles, Mumps, Rubella) - Any combination of monovalent or trivalent vaccinations to equal:

- Two (2) doses of measles and two (2) doses of mumps, and one (1) dose of rubella.
- If no vaccination records exist or they are incomplete, lab titers are accepted. They must show results for measles, mumps, and rubella individually.
- If a lab titer is equivocal or negative, subsequent vaccinations must be documented to show immunity.
- For an equivocal or negative measles or mumps titer, two (2) doses of MMR post titer must be documented.
- For an equivocal or negative rubella titer, one (1) dose of MMR post titer must be documented.

## **VZV (Varicella/Chicken Pox) -** Provide proof of immunity to chickenpox:

- Two (2) varicella vaccines.
- Must be spaced at least 4 weeks from each other, and the first one must have been given at twelve (12) months of age or greater.
- A positive lab titer. A negative of equivocal titer can be treated by two (2) doses of varicella vaccine at any point before or after the titer.
- Documentation from a Provider (not a self-report or parental report) of history of chicken pox disease at the time of disease.

**Tdap** - Provide proof of one (1) Tdap vaccination within the previous 10 years.

TB/PPD - Either QuantiFeron (blood testing) or tuberculin skin testing (TST) are accepted

- For QuantiFeron testing: a negative test within the last year must include date placed, date read and millimeter reading
- For TST: two (2) step test must include date placed, date read and millimeter reading, at least 7 days apart but within the same 12-month period.
- If there is a positive TB screening at any time, a chest x-ray is required. (Please email for additional details)

Hep B - Provide proof of one (1) positive Hepatitis B antibody by titer, or a signed Hepatitis B Waiver.

- 4) **During the onboarding process**, individuals will also be asked to acknowledge MHS policies as well: HIPAA, Standards for Business Conduct, Confidentiality and Use of electronic systems. You will have 7 days to complete uploading all your documents and the Mandatory Education module.
- 5) Individuals will also be asked to complete MultiCare's Mandatory Education module (45min 1hr) which is an interactive online course provided through an external MultiCare website.
- 6) Learner's valid Washington State nursing license or valid compact license. (You can go to: https://nurse.org/articles/enhanced-compact-multi-state-license-eNLC/ to find if you are part of the Nursing Licensure Compact.)

Or you may apply for a temporary nursing license for the State of Washington

Online pre-requisites for attending the workshop (these courses are in your online account and must be completed prior to the workshop).
