

Nurse Spotlight: Matt Ostroff 💡

Matthew Ostroff is an Advanced Practice Nurse Practitioner and the Coordinator and Founder of the vascular access program at St. Joseph's Health. His program has received multiple accolades, including the 2016 New Jersey Biz Healthcare Hero Award and the 2023 ANCC Magnet Award for Innovation, serving a diverse patient population from neonates to adults. Matthew has presented at national and international conferences focusing on critical thinking in complex patient scenarios. He is also the author of "Ultrasound-Guided Vascular Access: Practical Solutions to Bedside Clinical Challenges" (2022) and has published extensively in peer-reviewed journals.

What do you find most interesting about your position/industry?

The most rewarding aspect of my current role as a Vascular Access Coordinator and Nurse Practitioner is the strong support system that exists between myself, my director, and our corporate leadership. My leadership has witnessed and supported my professional growth—from managing PICC lines to tunneled catheters, and now ports—allowing me to develop innovative approaches to care for our diverse patient populations, ranging from neonates to adults.

What is your current focus and/or what projects are you currently working on?

I am prioritizing the training of new team members, utilizing an apprenticeship model that ensures a safe and controlled learning environment and enhancing the skills and scope of practice of our current team, which now includes mid-thigh femoral catheters and arterial access. Our team is also working on a 10-year retrospective review publication, analyzing data from our ultrasound-guided peripheral intravenous catheters to examine statistics related to device gauge and vein placement.

What advice would you have for someone entering the field?

The best piece of advice I wish I had received when entering this field is to immerse myself in the literature. Vascular access is far more than just a procedural skill; evidence-based research provides invaluable insights into the techniques, approaches, and the challenges and complications we may face. Lastly, I emphasize to others that no one is perfect—embrace both your successes and failures as opportunities to grow and continually improve as a clinician.

QUESTION

I have caused a stir with the Chief Nursing Officer at my facility in regards to splints/armboards at points of flexion. She is telling me (sternly), that these are forms of restraints, and it is illegal to apply these to patients.

How do I get through to her that I am not asking nor expecting anything illegal to be performed? It doesn't matter what the INS standards say, cause she believes INS is asking us to restrain people.

I can't even get the facility to teach new hires how to appropriately start an IV. I am at my wit's end, and the more I push and cite the standards, the more they put me under their thumb.

ANSWER

While you and your CNO are both correct that restraints that restrict mobility are detrimental to patients' well-being, splints and armboards do not fall in the same category. An IV joint stabilizer/IV site protection product may not be considered a restraint and is appropriate when it does not limit the patient's movement and is not tied to the bed. Alternatives like the TLC splint are less restrictive because they can be contoured to the individual patient.
